

## NOTICE FOR DEHRADUN PH-II SCHEME

IT IS INTIMATED THAT REFUNDS WITH 4% INTEREST WERE MADE TO DEHRADUN PHASE II ALLOTTEES WHO HAD OPTED FOR WITHDRAWAL FROM THE SCHEME IN 2016. THIS OPTION WAS MADE AVAILABLE ONLY FOR A LIMITED PERIOD TO THOSE ALLOTTEES WHO APPLIED FOR REFUND WITHIN THE GIVEN PERIOD. **THE PAYMENT OF INTEREST WITH REFUND AMOUNT WAS, HOWEVER, NEVER APPROVED BY THE COMPETENT AUTHORITY.** FURTHER IT MAY BE NOTED THAT THE DECISION WAS ALSO AGAINST THE PROVISIONS OF MASTER BROCHURE OF AFNHB WITH REGARDS TO REFUNDS.
