## **COSTING AND INSTALLMENT SCHEDULE**

- 1. The Board is pleased to inform all allottees of AFNHB Mysore scheme, that consequent to obtaining all necessary approvals tendering process has been completed and contract awarded. Construction activities in the project are expected to **commence in mid Aug 15** and be **completed by Mar 18 (tentatively)**.
- 2. Execution of the project will be undertaken by M/s GJS Infratech Pvt Ltd a Hyderabad based firm. The firm has been awarded a comprehensive contract inclusive of all Civil Works, External Electrification, lifts and External Developments. The contract is Lump Sum at a cost of Rs.171,08,48,117/- Crs with escalation payable only on steel, cement, tiles and granite. It is also pertinent that based on finalized specifications, the expected cost of construction as worked out by the Architect M/s Khan Global Architects in 2014 was Rs.172.74 Crs.
- 3. Initial tentative costing of DU's intimated in your allotment letter was based on a cost of Rs. 1808/per Sq Ft at 2012 rates. These were as follows: -

<u>Note</u>: Stilt parking will cost an additional amount of **Rs. 3.46 lacs**. Apart from it the sub heads mentioned at Para 5 of allotment letter would be additional to the tentative cost mentioned above.

- 5. Following factors have impacted the cost of DUs:-
  - (a). As per Mysore Urban Development Authority (MUDA) bye laws and permissible Floor Area Ratio (FAR), the total no. of DUs had to be reduced to 388 against the original 460 planned.
  - (b). Inflation from 2012 to 2018 approx @ 7% per annum.
- 6. It is also pertinent that the revised cost of **Rs.2570 Per Sq Ft** as above, includes the cost of land and is quite comparable to rates of ongoing local projects (Rs 3200 5300 per Sq Ft) and of AWHO at Mysore (Rs. 2900 per sq ft excluding land).
- 7. The installment plan has been worked out to maintain requisite cash flow to the project and is placed at **Appendix 'A'** for compliance.
- 8. Allottees wishing to withdraw from the scheme because of the increase in the cost of dwelling unit, as brought out at Para 4 above, may intimate the same to the AFNHB HQ by **15 Sept 15**.

Cancellation charges will not be levied for such allottees, and the amount paid will be refunded with saving bank rate of interest of 4 %.

- 9. Withdrawal sought after **15 Sept 15** will be processed in accordance with Clause 0702 of Chapter VII of the Master Brochure 2012.
- 10. Allottees who withdraw as per Paras 8 or 9 above and subsequently wish to rejoin/re-register in the scheme, will not be accorded any priority and will be considered as new applicants for all intents/purposes.
- 11. Other terms and conditions of allotment letter would remain unchanged.
