NOTICE FOR ELECTION OF MANAGEMENT OF SOCIETY JAL VAYU TOWERS, JAIPUR PHASE-II

- 1. The AFNHB project Jaipur has been completed and partial completion certificate issued by JDA on 28 Oct 21. Handing /Taking over of DUs and registration is in process. Now the common facilities have to be taken over by the Association/RWA for upkeep and maintenance. Thus, role of society is important at this juncture. Therefore, it is proposed to hold election for 11 members for governing body of the Association/RWA who will further elect following office bearers amongst them:-
 - (i) President
 - (ii) Vice President
 - (iii) Secretary
 - (iv) Treasurer
- 2. Interested allottees may file their nomination with AFNHB HQ for election of governing body members at email id afnhb.org by 22 Nov 21. Nomination can be withdrawn till 24 Nov 21. Election will be held at project site on 04 Dec 21 (Saturday)
- 3. All allottees are required to cast their vote through ballot paper physically at project site for selection of members of governing body of the Association. Counting of votes will be done at site on the day of election i.e. 04 Dec 21.
- 4. SOP/Guidelines for smooth conduct of election for governing body of the Association are as follows:-
 - (a) Capt DK Rai, GM (Admin), AFNHB will be electoral officer.
 - (b) Interested allottees may forward their nomination to AFNHB HQ on due date with dwelling unit number and status of possession.

- (c) The names of the candidates contesting election shall be uploaded on AFNHB website on 25 Nov 21.
- (d) Complete process of election will be carried out by physical voting with ballot paper only. Ballot paper shall be provided at site on the day of election. The voting process wills start from 1000 hrs to 1300 hrs on 04 Dec 21. No request for voting after expiry of this time shall be allowed.
- (e) Only original allottees are entitled to cast the vote and not joint registrant. It means one flat one vote. However the original allottee can authorize his representative to cast vote on his behalf with due authority letter. Copy of such authority letter needs to be forwarded to AFNHB HQ at email ibid and original copy to be shown by the authorized rep at the time of voting.
- (f) Allottes are advised to carry their Identity Card/Adhar Card/ Voter Card for verification of their identity.
- (g) The allottee/voter will have choice to select 09 candidates out of total candidates reflected in the ballot paper by putting tick mark in the column against the name of candidate of his choice and remaining block are to be crossed. No block is to be left blank.
- (h) While casting vote, allottee has to indicate his name, flat number, contact number and signature at last of the ballot paper.
- (j) Counting of votes will start at 1400 hrs on the day of election at project site and result will be declared on completion of counting.
